

**Fly With The Systems Depot and Win Promo Giveaway Sweepstakes
- 2017 Official Rules -**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. TO ENTER: You may enter the Fly With The Systems Depot And Win Promo Giveaway Sweepstakes (“Sweepstakes”) in one of three methods: (1) automatically be entered by purchasing qualifying Honeywell (“Vendor”) security products valued at or above \$500.00 at any participating Systems Depot location during the promotional period (one automatic entry for each \$500.00 increment (e.g., if participant purchases products for \$1500.00, will automatically be entered 3 times)); (2) e-mail your name, company name, mailing address, daytime phone number and e-mail address to sweepstakes@sdepot.com; or (3) legibly hand-write your name, company name, mailing address, daytime phone number and e-mail address on a piece of paper at least 3” x 5” and mail it to Fly with the Systems Depot Sweepstakes, PO Box 200, Hickory, North Carolina, 28603. ELIGIBILITY: Open to legal U.S. residents (excluding residents of Rhode Island, New York and Puerto Rico) who, as of August 15, 2017, are 25 years of age or older and employed as an officer, director or principal of a licensed security dealership that has an open account and is in good standing with Sponsor.
